The following items modify the plans and specifications and shall become a part of the contract documents.

QUESTIONS

Item 1: What is the anticipated construction start date and duration for this project? The RFP shows a completion date of November 2026.

Answer - Once the job is bid and the GC contract is finalized, Dallas ISD will issue the NTP for construction. This job should take more than 8 months to complete.

The Division 00 documents show a Substantial Completion date of 11/5/2026 and Final Completion 60 days after.

Item 2: Are there any specs for the school lettering rendition on sheet A3.04 details 3 and 4?

Answer – Refer to updates on 4/A3.01. Basis of design as manufactured by Fast Signs.

Item 3: Will be needing terrazzo specs to match existing. S5.02 detail 1 and 2 are showing a base, per TDG it will be a terrazzo base. Current plan set does not have specs.

Answer - As-built manufacturer information is not available, so it will be hard to match existing terrazzo. Please provide rubber wall base throughout the new vestibule walls. Color to be selected by architect.

Item 4: Interior material schedule A3.01 provides manufacturer and color but no further specs. Attached is what I assume the product would be "Blade Bafl",

Answer - Correct, the product is "Blade Bafl" by *Frash*, as listed on the Interior Material Schedule. The baffle colors are Indigo Blue 21, and Blue 30, installed per detail 4/A2.03.

Item 5: Plans call for ACT only to be replaced existing grid to remain, with this existing grid damaged is this now expected to change both the ceiling grid and tiles?

Answer - Protect existing grid to remain. Clean and reinstall the supply/return grills and reinstall per 1/M1.02. Provide new acoustic ceiling tiles.

Item 6: Sheet A2.03 detail 1 calling for new pipe insulation, is this only for the (2) sinks at each end as noted in the plans or are we to assume all sinks in the boys restroom only, or should it be at both restrooms?

Answer – New pipe insulation is needed <u>only</u> for the two sinks at each end in the boys restroom.

Item 7: On Site Plan Sheet E0.10, are all Fixture W's meant to be quoted or only the one's with Note 2 / Note 3. Provide information which Fixture W's are meant to be quoted for.

Answer - All fixture W's meant to be quoted. Keynote contains typical so that it applies to all wallpack W fixtures.

Item 8: Is ERRC or Cellular Coverage required?

Answer - Wireless communication with Fire Station included in general notes to be carried out under delegated design.

Item 9: Is there an approved staging area/laydown/temporary job trailer location?

Answer - Refer to 2/G0.05 for proposed laydown area.

Item 10: Is there an abatement report?

Answer – The building has been inspected, and it has been determined that the abatement report is not required.

Item 11: Is there a Geotechnical report?

Answer – The scope of work is mainly interior work, so a geotechnical report should not be needed. A survey for the parking lot improvements is currently being done, but this portion of the scope will be part of a separate package.

Item 12: Please confirm what is the description, color, size of the requested wall covering 'WC1'

Answer – WC1 is premium wall vinyl with matte lamination, to be provided by Versa Printing. They installed the wall covering on the north side wall of the corridor and will be providing the same lamination for the wall behind the new reception desk. Refer to Interior Material Schedule for Versa Printing contact information.

Item 13: What is the existing Solid HM doors with vision glass manufacturer?

Answer – As-built manufacturer information is not available, please verify in field.

Item 14: Please confirm Fire Alarm is only required on 'In Scope' areas, in lieu of cross hatched region per note 3-page FA1.01

Answer - Fire alarm replacement is for entire system and includes notifier and annunciator.

Item 15: Can we have access to previous RFI's responses?

Answer – Responses to the questions from all bidders have been compiled into this addendum.


