## 1.1 GENERAL

- A. This addendum modifies the drawings and project manual, dated December 9, 2025, as noted within and shall become part of the Contract Documents.
- B. Bidders shall acknowledge receipt of this addendum in the space provided on the bid form. Failure to do so may subject bidder to disqualification.
- C. Each holder of bid documents registered with the Architect will receive a copy of the addendum. Each prime bidder is responsible for distribution of information conveyed by this addendum to its sub-bidders and suppliers.
- D. Proposers shall acknowledge receipt of this addendum in the space provided on the proposal form. Failure to do so may subject proposer to disqualification.
- E. A pre-proposal conference was held at 2:00 p.m., local time, December 18, 2025 in the Room 1200J of the Education Support Center.

## 1.3 SECTION 05 50 00 – METAL FABRICATIONS

- A. Page 05 50 00 – 5, delete paragraph 3.3, O. entirely and replace with the following:

**"Safety Nosings: Balco, AS-2 abrasive cast aluminum nosings as detailed for hardwood steps.**  
1. Nosings shall be 1/4" wide, lengths as indicated on the drawings.  
2. Furnish nosings with adhesives and anchors for installation into hardwood treads.  
3. Install in strict accordance with manufacturer's written instructions and recommendations for conditions indicated.  
4. Color as selected by Architect from manufacturer's full range."

## 1.4 SECTION 05 58 13 – COLUMN COVERS

- A. Delete this section entirely.

## 1.5 SECTION 06 25 00 – PREFINISHED PANELING

- A. Page 06 25 00 – 2, delete paragraph 2.1 A and replace with the following.

**“Basis of design: Provide prefinished paneling as indicated on Drawings.**

A. **Subject to compliance with requirements, other acceptable manufacturers may include:**

- a. **PSI Wall Panel Systems**
- b. **Marlite Surface System”**

## **1.6 SECTION 06 64 00 – PLASTIC PANELING**

A. Page 06 64 00 – 1, delete paragraph 2.1, A. and replace with the following:

**“General (RP-01): Provide 3form **Varia** panels, 3/8" gauge by sizes indicated, as manufactured by 3form USA (phone: 800.726.0126 web site: www.3-form.com). Color(s) shall be as selected by Architect from manufacturer's complete color line.”**

## **1.7 SECTION 09 65 00 – RESILIENT FLOORING**

A. Page 09 65 00 – 3, delete paragraph 2.1, C. 1. and replace with the following:

**“1. Stair tread: square nose, type Roppe No. **96 Vantage with Riser.**”**

## **1.8 SECTION 09 65 66 – ATHLETIC SHEET FLOORING**

A. Page 09 65 66 – 3, delete paragraph 1.7 and replace with the following:

**“A. Warrant the work specified herein for five (5) years against becoming unserviceable or causing an objectionable appearance resulting from either defective or nonconforming materials or workmanship.**

**B. Defects shall include, but not be limited to the following:**

- A. **Shrinking, cracking, or otherwise deteriorating excessively.**
- B. **Becoming loose from substrate.**
- C. **Failure due to unusual exposure to moisture or other abusive forces or elements.”**

B. Page 09 65 66 – 3, delete paragraph 2.1, A. and replace with the following:

**“A. Basis of design Athletic Sheet Flooring (SF-01, SF-02, SF-03): Provide indoor resilient multipurpose surfacing as indicated on Materials Finish Schedule.**

A. **Subject to compliance with requirements, other acceptable manufacturers may include:**

- a. **Tarkett Sports**
- b. **Gerflor**
- c. **Mondo**
- d. **Tuflex”**

B. Other products may be approved as equal if deemed qualified and submitted in accordance with SECTION 01 25 13 – PRODUCT SUBSTITUTION PROCEDURES.”

C. Page 09 65 66 – 4, delete paragraph 2.1, G. entirely.

D. Page 09 65 66 – 4, delete paragraph 3.1, G. entirely.

E. Page 09 65 66 – 5, delete paragraph 3.4 and replace with the following:

### **“3.4 CLEANING**

- A. **Upon completion of work herein, clean all finish flooring surfaces so they are free of foreign matter.**
- B. **Remove all excess and waste materials from the area of work.**
- C. **Protect the finish work until acceptable by the Owner.”**

## 1.9 SECTION 10 26 13 – CORNER GUARDS

A. Page 10 26 13 – 1, delete paragraph 2.1, and replace with the following:

**"A. Stainless Steel Corner Guards: Provide corner guards as manufactured by Construction Specialties shall be manufactured from Type 304 stainless steel (meets NSF Standard 51), 16 gauge, #4 Satin Finish, 90°, 1/8" radius, or degree/radius necessary for applicable corner, with 1-1/2" wing, 8 foot length. Fasteners shall be pre-drilled beveled holes and Phillips head screws.**

1. Provide one of the following products/manufacturers:

- a. **Model CO-8; Construction Specialties**
- b. **Model CG-50; Pawling Corporation**

**"B. Vinyl Corner Guards: Provide Korogard GW15, G100-series as manufactured by Koroseal. Surface mounted guards consisting of a continuous high-impact extruded vinyl acrylic, vinyl wallcovering wrapped. Length as indicated on drawings. Color as specified in drawings."**

## 1.10 SECTION 10 28 00 – TOILET ACCESSORIES

A. Page 10 28 00 – 2, delete paragraph 2.3, D. and replace with the following:

**"D. Mirrors (C2): Model B-290 2436."**

B. Page 10 28 00 – 3, delete paragraph 2.3, G. and replace with the following:

**"G. OFCI - Sanitary Napkin Disposal Units (E1): Model B-270."**

C. Page 10 28 00 – 3, delete paragraph 2.3, H. and replace with the following:

**"H. OFCI - Soap Dispensers, Wall-Mounted (F1): Model B-4112."**

## 1.11 SECTION 10 73 26 - PREFABRICATED WALKWAY COVERS

A. Page 10 73 26 – 2, delete paragraph 2.2, E. 2. entirely.

B. Page 10 73 26 – 2, add paragraphs 2.2, F. and 2.2 G. as follows:

**"F. Provide bird screening at fluted conditions.**

**"G. Provide bird guards above beams and under deck to prevent roosting."**
